this book contains an explanatory treatment of the core areas of difficulty for the english speaking learner of french it deals with the key issues in tense formation and use and verbal structures and processes such as negation passives and subjunctives along with a highly exemplified treatment of pronouns and a section dealing with adjectives and other elements of the grammar it fills a gap between general text books of french in which grammatical issues are frequently treated piecemeal and scattered throughout the book in between more communicative information on one hand and exhaustive reference grammars aimed at graduate and research students on the other which would be beyond the level of intellectual maturity of most school children and some non specialist undergraduates it has the advantage of treating each grammatical issue in detail but without being too long winded explaining the systems and processes which underlie the facts of the language the emphasis is on explanation and not merely the listing of facts enabling the learner to master the system and become an independent user of the language it could be used highly successfully either as a classroom aid alongside the more usual textbooks which are organized typically around topics and themes in society or for self study for the committed individual learner of any age there are extensive exercises and answers for all topics covered

the notion of focus structure in this work refers to the distinction between categorical thetic and identificational sentences the central claim is that the syntactic representation of every sentence has to encode which of these types of focus structure is realized this claim is discussed in great detail with respect to syntax intonation and semantics within the framework of the minimalist program it is shown that the incorporation of focus structure into syntax offers new perspectives for a solution of vexing problems in syntax and semantics for example fronting preposing topicalisation is treated as a syntactic operation which clearly belongs to core grammar i e is not optional or stylistic the semantic notion of quantifier raising is dispensed with in favour of a focus structural treatment of phenomena which gave rise to it the book appeals to generative linguists and to functional linguists who do not believe in an unbridgeable gap between the formal and functional analysis of language

this volume emphasizes a new line of thinking in generative grammar which acknowledges that certain synchronic properties of languages can only be fully understood if diachronic data is taken into consideration the central topics addressed in this collection of papers are 1 a critical assessment of the hypothesis that certain apparently synchronic generalizations are actually the result of the mechanisms of language change 2 an inquiry into how diachronic data can be used to evaluate and shape formal analyses of particular synchronic phenomena reviving the interest in diachronic explanations for synchronic data the contributions provide novel and original diachronic accounts of phenomena that up to now have escaped a deeper synchronic explanation including the nature of epp features gaps in the distribution of complementizer agreement and counterexamples to the generalization that rich verbal inflection correlates with verb movement

the claim that pronominals have phonological features only where they must for some reason is strongly supported by the occurrence of the null pronoun pro as coined and introduced by noam chomsky how reference of pro is determined is the main subject of control theory the subsystem of core grammar to which this study is dedicated chomsky has not followed up his natural suggestion that choice of controller is determined by theta roles or other semantic properties of the verb perhaps pragmatic conditions of some sort but then a great many students of control have engaged in exploring thematic roles as tools most suitable for investigating control shifting analysis of control to the relationship between thematic features carried by pro and its potential controller respectively was a
